Subject: **REMINDERS ON THE REPORTING OF VACCINATION DATA
FOR DECEMBER AND DEPED'S PARTICIPATION IN THE
NATIONAL VACCINATION DAYS**

The DepEd Task Force COVID-19 (DTFC) reminds Regional COVID-19 Response/Vaccination Focals that **the reports for December are due for submission on 21 December 2021** through email at blss.od@deped.gov.ph (cc: blss.shd@deped.gov.ph).¹

Consistent with DTFC Memorandum No. 531 (*Reminder on the Reporting of Vaccination Data by Regional Focals*), the template to be used for reporting shall be the same template used for the months of October and November. This template can be downloaded from <https://bit.ly/vaccreporttemplate202110>.

In this connection, the DTFC reiterates the following reminders:

1. entries should be complete and all cells properly filled;
2. the designated row for the region in the National Summary Sheet must be filled out;
3. the total percentage should not be more or less than 100%; and
4. when the number of personnel per category (teaching/non-teaching) is summed up, the total should be equal to the total number of eligible population.

Regional Focals are also reminded to submit their reports on DepEd's participation in the first round of the National Vaccination Days (NVD)² which should have been submitted on 10 December 2021.³


